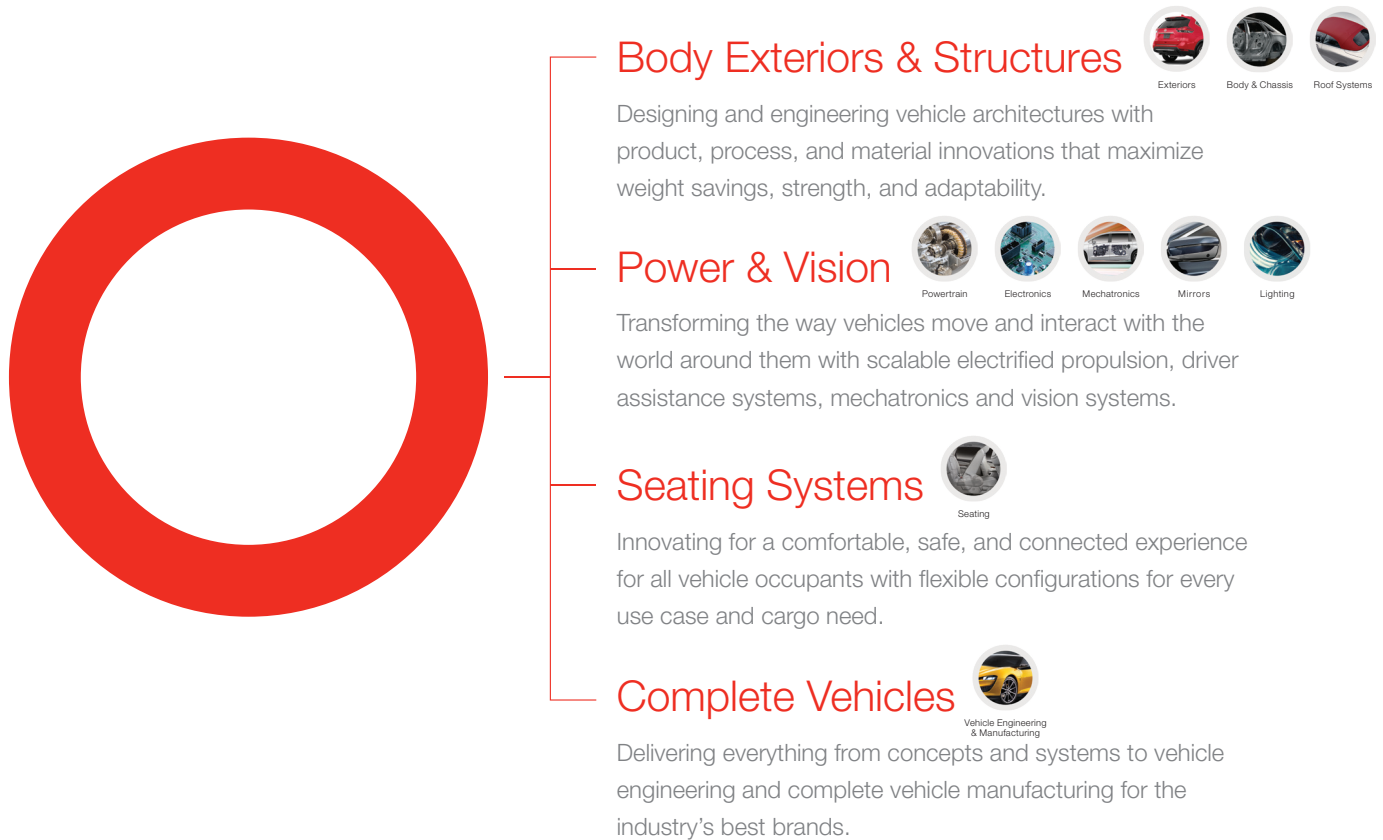

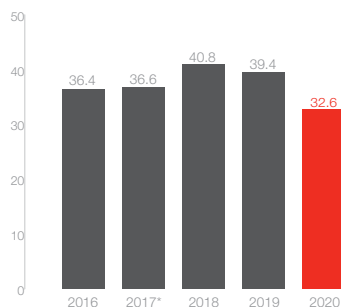

(Years ended December 31,)

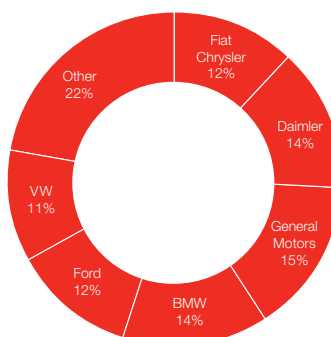
U.S. \$ Billions

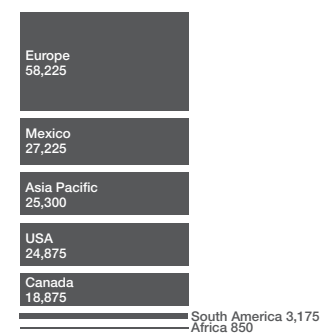
Global Sales by Customer
